A RESOLUTION OF THE MILESBURG BOROUGH WATER AUTHORITY, CENTRE COUNTY, PENNSYLVANIA ESTABLISHING THE CAPITAL CHARGES FEES TO BE IMPOSED BY THE AUTHORITY PURSUANT TO ACT 57 OF 2003.

WHEREAS, the Milesburg Borough Water Authority has established certain fees to cover the cost of providing water service to Milesburg Borough and Boggs Township, and

WHEREAS, said fees are to be increased by Resolution from time-to-time as determined necessary by the Authority; and

WHEREAS, the fees set forth herein have been calculated and by Herbert, Rowland and Grubic, Inc., consulting Engineers, pursuant to regulations of the Commonwealth of Pennsylvania (Act 57-2003), and are recommended by the Milesburg Borough Water Authority, and made part of this resolution.

The tapping fee for a Non-Residential connection will be based on meter size and the number of gallons per day required by the new connection and computed as follows:

Capacity Part	\$ 2.20
Distribution Part	\$ 4.98
Total (per gpd)	\$ 7.18

1.0"	\$1,500.00
1.5"	\$2,200.00
2.0"	\$3,500.00

The Tapping Fee for meter sizes above 2.0" and for all fire service connections will be individually calculated based on meter size and type, service location and line capacity.

The Reservation of Capacity Fee is:
